### *Information From HR Regarding BCBS Medicare Supplemental Insurance*

Retirees on Medicare and OSU's BlueCross BlueShield (BCBS) Group Supplemental Plan are **not** affected by the contract negotiations with Stillwater Medical Center (SMC), which could lead to SMC's going out of network. SMC is remaining a provider with Medicare and thus the OSU BCBS supplemental plan will still be accepted as in-network. Medicare will continue to pay primary and your OSU BCBS supplemental plan secondary.

OSU retirees who are under age 65 and on the OSU active group plan, BlueOptions or BlueEdge, will be affected if agreements are not reached to remain in-network at Stillwater Medical Center, Stillwater Medical - Perry, and Stillwater Medical - Blackwell. BCBS has acted as our third-party administrator, negotiating on our behalf with the intent to keep our medical costs down while allowing reasonable increases due to the nationally rising costs of healthcare. As our group health plan is self-insured, these increased costs are shared between OSU, its employees and pre-Medicare retirees.
