

### **GENERAL INFORMATION**

**MEMBERSHIP:** Membership in the OSU Emeriti Association is open to all retired employees of OSU (faculty and staff), spouses of current or deceased Emeriti members, retired federal personnel associated with OSU, Board of Regents, and retirees from other A&M institutions. Other retirees with a significant relationship to OSU may become members upon approval of the Council.

**DUES**: Annual Membership dues are \$25.00 per person or \$35.00 per couple and are due and payable each year on January 1. Dues must be received by March 1 for the member's name to be included in the annually-updated directory. Life Membership may be purchased for \$200.00 per person or \$250.00 per couple. Life membership does not expire and does not have to be renewed. Checks for annual dues and life membership should be made payable to the OSU Emeriti Association.

**MEETINGS**: No fewer than eight meetings of the Association are scheduled by the Council each year. Typically, these are dinner meetings held on the first Monday of each month with exceptions for summer and January. In order to ensure adequate food, reservations are required in advance. Information regarding the meetings is emailed (or mailed) to each member.

**NEWS AND PERIODIC INFORMATION:** A calendar/UPDATE and other information may be distributed at each monthly dinner. Newsletters are mailed to members twice a year. The Emeriti website provides up-to-date information.

**VOLUNTEERS:** Requests for Emeriti member volunteers to serve at campus or other events should be referred to the chair of the Emeriti Ambassadors.

**FACILITIES:** Requests by non-member groups to use the Emeriti Association facilities shall be brought to the Council for consideration. If approved, an agreement will be signed with a responsible representative of the organization making the request.

**OFFICERS AND COMMITTEE CHAIRS:** Each officer and committee chair shall update his/her job description yearly. Job descriptions are provided to each new officer or committee chair and made available to the nominating committee for use in contacting candidates.

## **EMERITI BENEFITS**

Information regarding benefits is subject to change during the year. Please contact the appropriate agency or department for more information. Also, some departments or programs listed herein may have different rules for Emeriti Association members who are retired faculty and staff and those who were not retired from OSU.

**Apple Computer Discounts:** Academic discounts on Apple Computers are available at the Student Union Bookstore. A valid OSU ID must be shown at the time of purchase. For more information, contact the Bookstore at 405-744-4357.

**Auditing Courses:** Retirees may audit OSU courses (except Music, Art, or lab classes) at no cost. The instructor's permission is required to audit. Call the University Registrar for details: 405-744-6876.

**Campus Parking Permits:** Retired OSU employees with 20 years or more of service and 20 consecutive years of obtaining an OSU parking permit are entitled to receive an Emeritus parking permit at NO COST. The permit is obtained from the Transportation Center at the corner of Hall of Fame and Monroe. These permits must be renewed each year. Other retirees may obtain a day pass. Parking permits are valid ONLY for the personal use of the retirees to whom they are issued and cannot be loaned to students, friends, or family. Parking permits of deceased OSU retirees must be returned and may not be used by their widows/widowers. Call 405-744-4324.

**Cohn Family Small Animal Shelter:** The Cohn Shelter, located at 1407 N. Western, will board small animals of Emeriti as space allows. Call 405-744-3647 for information, daily fees, and directions.

**Edmon Low Library**: Retired faculty and staff may check out books, software and other permissible materials for 180 days. An OSU/Emeriti ID card is required. Also, Emeriti members may access digital library services through the internet at <u>http://library.okstate.edu/dls/</u>. For help, call the librarian at 405-744-9780.

**Email:** Retirees can keep their OSU email addresses. For questions regarding an O-Key account, contact the IT Help Desk at 405-744-4357.

**ID Cards**: While current OSU photo ID cards will remain valid in retirement, a new ID card can be obtained in 113 Math Science Building. Lost cards are to be reported immediately as they can, among other things, be used for purchases at the Library and the OSU Bookstore. There is a charge to replace lost cards. Call 405-744-8434 for more information.

**Lake Carl Blackwell (LCB):** There is no charge for day visitation for OSU Emeriti and spouses. A "day use" pass is required and can be acquired by showing an OSU Emeriti card at the LCB Headquarters (store) or the Fee Collection Booth. There are no longer any discounts on daily or annual boating or fishing permits. Vehicles not displaying a permit are subject to ticketing by OSU PD. Call 405-372-5157 for details.

**U Music Department**: With the exception of the Masterworks, all concerts tickets may be purchased by Emeriti members and senior citizens at the current student rate. For a list of upcoming events, check <u>http://music.okstate.edu</u> or call 405-744-8997.

**OSU Sporting Events:** Season tickets for OSU home games may be purchased by OSU retirees for the same discounted price that is offered to active faculty and staff. Retirees are limited to two tickets for men's basketball and four tickets for all other sports. When purchasing in person at the Athletic Ticket Office, retirees must present their OSU ID cards in order to receive the discount. If ordering by mail, they must include a photocopy of their ID cards. Call 405-744-5745 for details and ordering information.

**OSU Theatre**: Retired faculty and staff are eligible for season tickets at a reduced rate. For upcoming events, check <u>http://theatre.okstate.edu</u> or call 405-744-9208.

**Parking in Student Union Garage:** OSU Emeriti are provided a 50% discount on hourly parking in the SU garage with a minimum charge of one hour of parking at the current rate. Current Emeriti ID must be presented to the parking attendant to receive benefit.

**Transit System:** Citizens over the age of 60 may ride the local OSU orange buses one way for twenty-five cents. Currently, the Tulsa service is restricted to students and faculty.

**University Club at Oklahoma State University**: Emeriti members are eligible to join the University Club (U-Club). For details on U-Club membership, benefits, the event calendar and other information, visit the U-Club website at <u>http://uclub.okstate.edu</u> or send an email to <u>uclub@okstate.edu</u>.

**Wellness Department:** The University covers the membership fee for the Wellness Department (Colvin Recreation Center and Seretean Wellness Center) for faculty and staff who have retired from OSU. Retirees need only to show their University ID to be admitted.

#### **HIGHLIGHTS OF 2015**

OSU Emeriti Association

#### **Russell Wright, Association President**

The year 2015 was an active, productive year for the Emeriti Association. We added over 60 new members and look forward to continued growth. Early in the year, Council members Clem Ward and treasurer Ron Elliott investigated the possibility of utilizing a credit card system to facilitate the payment of meal charges and membership dues. This system has been implemented and is working very well.

A committee was formed to revise and update the Association's Constitution and Bylaws. This committee (David Lewis, Chair, Andrea Arquitt, Dennis Bertholf, Anne Matoy and Clem Ward) did an excellent job and the suggested changes were approved by members of the Association at the June meeting. I thank the committee and council for their work, discussions and suggestions during this process.

I thank Program Chairs, Ed Long and Gladeen Allred, for the many excellent, informative programs at the monthly meetings. I also thank Jack and Jodelle Stout for again organizing the Emeriti Association travel trips. These trips were well received and fun for all who participated.

The Association sponsors three very active special interest groups open to Association members and the public. These groups are the "Technology Interest Group" coordinated by Glade Presnal, the "Emeriti Investment Group" coordinated by Dennis Bertholf, and the "Making the Most of Retirement Group" coordinated by Zane Quible. I am very appreciative of all three of these coordinators and the terrific job they have done this year as well as several past years.

The Association also has an Emeriti Ambassadors group who assist Alumni Center staff by being greeters in the Alumni Center during home football games, assisting at the Alumni Center's front foyer desk when asked, and assisting the OSU Registrar's Office by serving as greeters handing out the official OSU graduation programs at all OSU undergraduate commencements. I thank Sharon Brown who formed and coordinates Emeriti Ambassador activities.

During the fall, the Council formed a Committee consisting of Clem Ward, Zane Quible, and Ron Elliott to determine the feasibility and procedure to form an Emeriti Association Undergraduate Endowed Scholarship through the OSU foundation. As of December 11, I signed an Endowment Agreement between the OSU Emeriti Association and the OSU Foundation to create the Oklahoma State University Emeriti Association Scholarship Fund. This scholarship has been endowed at \$25,000 and should earn enough interest to grant the first scholarship in the fall semester 2016.

I would like to express my appreciation to the OSU Provost's Office for their support in printing and mailing costs and to the administrative staff in the OLLI Office, especially Misty Burke who serves as our part-time administrative assistant.

I also appreciate and thank all the officers, councilors and the many volunteers of the OSU Emeriti Association who served this year. REMEMBER, the Emeriti Association is run exclusively by volunteers and is always in need of folks to serve as Association officers, councilors and committee members.
