## Past Leadership

The Emeriti Association was founded in 1988. Dr. Robert Henrickson spearheaded its development with support from then President Lawrence Boger and Provost Jay Boggs. A committee was appointed by the provost with leadership given to Dr. Henrickson and included three other retirees. The members of this committee are credited as the founding members of the Emeriti Association. Their names are shown below.

# Membership

Membership in the Association is open to all retired employees of OSU, spouses of current or deceased Emeriti members, retired Federal personnel associated with OSU, the Board of Regents, and retirees from other academic institutions within the Oklahoma A&M System. As contained in the Constitution of the Association, other retirees with a significant relationship to Oklahoma State University may become members upon approval of the Emeriti Council. # **General Information**

# **Constitution and Bylaws**

The Emeriti Association Constitution and Bylaws are on the Emeriti Web site. The Association Policies and Procedures and History are also on the Web site. Every odd year or as needed, the Constitution, Bylaws, and Policies and Procedures are reviewed and, if necessary, amended.

# Dues

Annual Membership dues are \$25.00 per person or \$35.00 per couple and are due on January 1. Annual dues not received by March 1 may cause the member's name to be excluded from the updated *Directory*.

Life Membership dues are \$200.00 per person or \$250.00 per couple. Life Membership is a one-time payment at the time the retiree joins the Association.

Checks for annual dues and life membership are payable to the OSU Emeriti Association and should be mailed to the Emeriti Association mailing address shown on the inside of the *Directory* cover. After a member has paid 10 years of annual dues, he/she is granted lifemember status and is not obligated to pay additional membership dues.

# **E-mail Address**

Because of the increased amount of Emeriti Association communication now being done by e-mail, it is important that members notify the Emeriti Association office when they change their e-mail address. This can be done by sending an e-mail to the Association office <<u>emeriti@okstate.edu</u>> or by sending a notice of change by regular mail to the address shown on the inside of the *Directory* cover.

# **Emeriti Council Business Meetings**

The Emeriti Council holds its monthly business meetings on the last Monday of the month except for December when the Council meets on the second Monday. Because of the Memorial Day holiday, the Council meets on the prior Monday. The Emeriti Council does not hold a business meeting in June and July. The business meeting location is the Emeriti Suite, Room 101 of the ConocoPhillips OSU Alumni Center. Inclement weather that closes the University on the day of the Emeriti Council meeting automatically cancels the Council meeting.

# **Facilities Requests**

The Emeriti Association facilities are located in the ConocoPhillips OSU Alumni Center. Requests by non-member groups to use the Emeriti Association facilities shall be brought to the Emeriti Council for referral to the Alumni Association for consideration.

# **Investment Club**

The Investment Club is an Association interest group for Association members who enjoy learning about stock market investing in a friendly, supportive environment. This group elects its own officers and is governed by a Partnership Agreement and set of Bylaws. Participation requires a modest financial commitment. Each member is a partner and has a share in the Investment Club's stock portfolio. Visitors are welcome at Club meetings. Those interested in joining are required to attend three Club meetings before applying to become a partner. Inclement weather that closes the University on the day of an Investment Club meeting automatically cancels the Club meeting.

# **Membership Meetings**

No fewer than eight meetings of the Association are scheduled each year. These are typically dinner meetings held on the first Monday of each month. Meetings are not held in January, July, nor August. An announcement about the meal and program is e-mailed (some mailed by request) to members. To ensure adequate food and seating, reservations are required by the date noted in the announcement. Inclement weather that closes the University on the day of a Monday Night Dinner meeting automatically cancels the dinner meeting.

# **Meet and Greet Reception**

The Meet and Greet reception precedes the monthly dinner meetings and allows additional time for informal interaction among the dinner attendees. The reception is held in the Emeriti Suite, Room 101, of the ConocoPhillips OSU Alumni Center. Light snacks and both nonalcoholic beverages and wine are offered. A small contribution is accepted to cover the expenditures for the reception.

# Members Age 90 and Older

Members age 90 and older receive a complimentary meal at the monthly dinner meetings. Please contact the chair of the Membership Committee when reaching age 90.

# **News and Periodic Information**

# Job Descriptions of Officers and Committee Chairs

# **Programs Committee**

# **Scholarship Program**

The Association has a scholarship endowment fund with the OSU Foundation. From it, an annual scholarship is awarded to two OSU students. Donations are welcome. There is the potential for a larger award as the endowment fund grows. A donation is an admirable way to honor and memorialize relatives and friends. Donations are payable to the OSU Foundation. ## **Retiree Benefits Information**

The Emeriti Association continues to be proactive in following and suggesting OSU programs and services beneficial to retirees. Various befefits currently available are described below. *Information regarding benefits is subject to change during the year. Please contact the appropriate department for more information and updates.* 

#### **Computer Discounts**

Academic discounts on Apple, Dell, HP, and MSI computers are available at the University Bookstore in the OSU Student Union. A valid OSU ID must be shown at the time of purchase. Call the Bookstore at (405) 744-4357 for details.

#### **Auditing Courses**

OSU retirees who retired under the OTRS Rule of 80 or Rule of 90 and anyone age 65 or older may audit OSU courses. Laboratory and studio art courses and private music lessons are not open for audit. The instructor's permission is required. A *Request to Audit a Course* form is available online at <a href="https://registrar.okstate.edu">https://registrar.okstate.edu</a>. Call the Office of Registrar at (405) 744-6876 for details.

#### **Campus Parking Permits**

OSU retirees who have 20 years of consecutive service and 20 consecutive years of obtaining an OSU parking permit are entitled to receive a retiree parking permit at no cost. A retiree with fewer than 20 years of consecutive service is eligible to purchase a staff parking permit at the current price. Parking permits must be picked up in person from OSU Parking and Transit Services located in the Multimodal Transportation Terminal. A parking permit is valid only for the personal use of the retiree to whom issued. Call (405) 744-6525 for more information.

#### **Edmon Low Library**

Retired faculty and staff may check out books and other permissible materials and access software. An OSU ID or Emeriti membership card is required. Emeriti members may access digital library services through the Internet at <a href="https://library.okstate.edu">https://library.okstate.edu</a>. Call the librarian at (405) 744-9780 for additional information or help.

#### E-mail

OSU retirees may retain their OSU e-mail addresses. For questions regarding an O-Key account, contact the IT Help Desk at (405) 744-4357.

# Lake Carl Blackwell (LCB)

There is no charge to OSU Emeriti members for day visitation. A "day use" pass is required and obtained by showing one's Emeriti membership card at the LCB Headquarters (next to the store) or the Fee Collection Booth (when open) at the entrance. Vehicles not displaying a permit are subject to ticketing by OSU Police Department.

#### **OSU Athletic Events**

OSU retirees may purchase reduced-priced season tickets. Call the Athletic Ticket Office at (405) 744-5745 for ordering information and other details.

#### **OSU ID Cards**

OSU ID cards will remain valid in retirement. Lost cards must be reported immediately to prevent unauthorized use. There is a \$20 replacement fee. The ID Services office is located in 421 Classroom Building. Check <a href="https://it.okstate.edu">https://it.okstate.edu</a> or call (405) 744-8434 for questions and additional information.

#### **OSU Michael and Anne Greenwood School of Music**

Tickets for music events are available at the current student rate for members of the Association and other senior citizens. Check the Web site <a href="https://music.okstate.edu">https://music.okstate.edu</a> or call (405) 744-8997 for a list of upcoming musical events and purchasing tickets.

#### **OSU Department of Theatre**

Senior citizens age 65 or older are eligible to purchase reduced-price tickets. Attendees with disabilities may request seating in a designated row. Check the Web site <a href="https://theatre.okstate.edu">https://theatre.okstate.edu</a> or call (405) 744-6094 for upcoming theatre events and purchasing tickets.

#### **OSU Student Government Association Events**

Most events sponsored by the OSU Student Government Association are free to OSU retirees with a valid OSU ID. This includes the OSU Speakers Board events. Admission restrictions and fee requirement likely will be listed in the advertisement for the event.

#### Parking in Student Union (SU) Garage

OSU Emeriti Association members are given a 50% discount on hourly parking in the SU garage. There is a minimum charge of one hour. A current Emeriti membership card must be shown to the parking attendant to receive the discount.

#### Seretean Wellness Center and Colvin Center

OSU retirees are given an automatic free membership to the Department of Wellness and only need to show their OSU ID to be admitted. Other Emeriti members who are not OSU retirees, such as spouses of OSU retirees or those who joined the Emeriti Association as a non-OSU retiree, may purchase membership on a semester or annual basis at the community membership rates. #### **Transit System**

Passengers reaching age 59 may ride the local OSU buses one way for thirty-five cents. The BOB transit service is available to the public at the same rate as for current faculty and staff. The one-way fare is \$13.00. Reservations are required for riding BOB. #### Highlights of 2022 OSU Emeriti Association

#### Kent Sampson, 2022 President

As we entered a post-pandemic time, much effort was expended in working to revitalize the organization and its many functions.

The Monday Night Dinners (MND) continued to be important to the membership. As 2022 president, I am most appreciative of and indebted to Michael Lorenz, who, as past-president, held my hand when needed to assure Association success. Mike and Velda, you are such assets to the Association! Thanks so very much!!

The OSU Emeriti Association is governed by a council consisting of 9 councilors (each on three-year rotating terms) and an executive team of six more members, making 15 members total.

Membership was stable at 445 members with an additional 16 joining as life members and four as annual members. A new membership policy was adopted by the membership and Council. It reads: "Once a member has paid for 10 years of annual dues, he/she will become eligible for a lifetime membership, never again paying dues." Annual members approaching this ten-year mark have been contacted and informed about their status. This change received positive response from the membership and was approved by the Council at its October 31 meeting.

The association's financial position remains excellent. The annual audit confirmed this! The December balances are as follows: Checking: \$2109.29; savings: \$10.20; money market: \$6578.79; and one certificate of deposit: \$5010.16. The December 2022 endowment has a value of \$65,063 while the scholarship fund is worth \$55,553.79. The Council still wishes to maintain MNDs at a participant cost of \$15, with the Association subsidizing each meal served for \$4.30 per person per evening, which includes food, gratuity, venue charges, set-up, audio-visual equipment, etc. NOTE: An anonymous donor wishing to maintain the \$15 fee per person has offered up to \$1000 to help with expenses.

Mike Lorenz, as chair of the Membership Committee, continues to invite retirees to join the Association and works with Coral White in OSU HR in identifying prospective members. Our group is also quite appreciative of the continued support of the Provost's Office and Denise Weaver.

On January 9, 2023, Past-President Sampson and President Gary Sherrer met with the new CEO of the ConocoPhillips Alumni Center, Dr. Ann Caine. A copy of the current working agreement was shared, and continued approval is anticipated. She seemed to be most interested in working with our group, including a revamped Ambassador program. We experienced limited success in our joint effort with Josh Taylor and the Hargis Leadership Initiative in offering emeriti mentors to students studying leadership. This program will continue to be pursued.

#### 2023 Emeriti Association Directory

Our partnership with OLLI and Director Robyn Davis continues to be solid. Her team is doing excellent work as they, too, emerge from the pandemic impact.

The 2022 year also experienced the passing of 18 Emeriti Association members including former dean of the Graduate College, Norman Durham, as well as former OSU president, Jim Halligan. The list of these individuals is contained in the *Directory*.

Dinner programs take place the first Monday of every month at 6 pm (with a social beginning at 5:30) except during the months of January, July, and August. The September dinner normally takes place on the second Monday of the month, and the May dinner is cohosted with OLLI. Council meetings take place the last Monday of each month at 1:30 except for June and July. Such meetings are held in the Emeriti Suite in the ConocoPhillips Alumni Center.
