**Minutes:** It was moved (Barbara) and seconded (Tana) that the minutes of the November 1 meeting be approved. The motion passed.

**Treasurer's Report:** Ron corrected a small error in the October report and shared the November report, which was received as presented. He also alerted the group that a C.D. will come due on February 1 and that the Council will need to make a decision in January regarding its use or reinvestment. Barbara asked if people would be able to pay dues at the upcoming December dinner and received a positive response. To simplify matters for those at the checkin desk, Sofia will indicate on the registration list whether or not attendees have paid previously. In response to Kent's question, Ron stated that the subsidy for dinners comes out of the ending cash balance. He reminded the Council that those funds cannot be used without justification.

#### Report of November 9, 2021, Faculty Council Meeting, submitted by Barbara Miller:

**Dr. Randy Kluver**, who is in charge for OSU with other Church Groups for Afghan refugee rescue, reported that 124,000 were evacuated in the two weeks following the U.S. evacuation of Afghanistan, many to military bases. About 37,000 were evacuated to the U.S. Oklahoma received about 1800, which is the third largest in the U.S. There are 40 families now in Stillwater. Due to COVID there were vacancies in Student housing, and about 25 families went into this housing, with about 15 families going to private housing. The plan is to keep families here, giving necessities and training, to enable them to relocate by March or April, most likely to form businesses and prosper. About 50 percent are under 18 years of age. We will have about 100-150 children who will be given ESL classes.... They can use OSU Buses, and are being provided with medical and COVID care already. About 60 percent speak Dari, which is close to Farsi, and 40 percent speak Pasha (sic) which is close to Hindi. OSU has speakers of Farsi and Hindi to help communicate with the refugees.

**Dr. Rita Peaser**, registrar, reported they are working with the Pandemic Planning task force, and delayed spring 2022 enrolment to allow departments time to work with faculty concerns. 90 percent of classes stayed in person, 2,538. There were 100 hybrid classes, and 95 online But most are traditional or hybrid..

**President Schrum** reported that Homecoming had a good turnout.

Infrastructure funds from the recently passed federal legislation will mostly be one-time projects, and OSU will bundle projects for best success with our state legislature. There will be a strategy planning meeting about these projects the second week in December. She announced that STEM education will be important in this funding. Allison Johnson, new chancellor for Higher Ed, was looking at our campus and how we compare with other schools. Proposals for funding after this year will depend on ARPA infrastructure payments. The funding formula has been frozen since the 90s and is being looked at. Meanwhile there will be a median 3 percent raise this year for faculty and staff.

She also noted that COVID numbers continue to improve. The case number is still below five percent, and only 5-6 people are in quarantine. The federal mandate for requiring all in businesses be vaccinated has a deadline of Jan.4. Oklahoma has joined the lawsuit against this requirement, so it remains to be seen how it will effect OSU.

There was a task Force report from the Pandemic Task force. Mindy McCain and Steve Clark reported that things look very good so far for spring semester. They are looking at COVID in relation to Tenure process with such items as student review of teaching, They are stressing that we are coming into a new use of technology, with COVID response providing the impetus. They are looking into disparities of effects of the virus on various Faculty groups.

The Board of Regents approved the Juneteenth Holiday to be added to the OSU schedule,

**Acting Provost Mendez** reported that there will be a detailed report on the Faculty Survey on Covid at the December Convocation.

The Graduate College approved several changes by various graduate programs in requirements for admission. See faculty Council official minutes on their web page for specifcs.
