Stillwater Medical Center Now in the BC/BS Medicare Advantage HMO and PPO Networks

As of May 1, Blue Cross and Blue Shield of Oklahoma welcomed primary care physicians and specialists affiliated with the Stillwater Medical Center to the BCBSOK Medicare Advantage (HMO)SM and BCBSOK Medicare Advantage (PPO)SM networks. Accordingly, BCBSOK mailed a letter mid-July to eligible OSU employees about the new offering. Information From OSU Human Resources

Retiree Life Insurance Benefits

Oklahoma Teachers' Retirement System (OTRS) provides retirees with a \$5,000 death benefit payable to one's designated beneficiary upon the retiree's demise. When one retires with OTRS, he/she would have completed a form to designate a beneficiary for this benefit. If you need to update this designation, you can locate the *TRS Form 2R* at <https://oklahoma.gov/trs/forms.html>. Upon the reporting of the retiree's death to OTRS, it will contact the designated beneficiary regarding the \$5,000 death benefit.

Oklahoma State University also provides retirees with a \$6,000 retiree life insurance benefit payable to one's designated beneficiary upon the retiree's demise. You may at any time update your beneficiary designation by completing and submitting the following form: <https://hr.okstate.edu/benefits/retiree-benefit.html> . Reporting of the retiree's death needs to be made to OSU Benefits, which will file the claim with Lincoln Financial, and Lincoln

Financial will submit paperwork to the designated beneficiary to finalize the claim for payment.

2025 Open Enrollment

OSU Benefits anticipates mailing open enrollment materials on or around October 9, 2024, and changes to your enrollment can be made between October 14 and November 8. Changes made during this time will become effective January 1, 2025. There will not be any vendor changes; health and prescription drug insurance remain with BlueCross BlueShield of Oklahoma, vision with Vision Service Plan (VSP), and dental with Delta Dental of Oklahoma. Rates for 2025 have not been finalized at this time. All retiree benefit information may be accessed online at <https://hr.okstate.edu/benefits/retiree-benefits.html>.

The Medicare Rx coverage gap phase has been eliminated in CY 2025, meaning a beneficiary will leave the initial coverage phase and enter the catastrophic phase once he/she incurs enough true out-of-pocket eligible costs to meet the annual out-of-pocket threshold, which is \$2,000 in CY 2025. Thus, retirees who have the Enhanced Rx plan may want to evaluate and consider changing to the Basic Rx plan for substantial savings on your monthly premiums.
